# POLARIS PROGRAMME "SUPPORTING MULTILEVEL GOVERNANCE IN UKRAINE" (2024-2028)

is funded by the Government of Sweden through the Swedish International Development Cooperation Agency Sida and implemented by SALAR International, an organisation representing the interests of the Swedish Association of Local and Regional Authorities (SALAR) in international activities.

The Programme aims to provide both short-term and long-term support, focusing on addressing the needs of multilevel governance while simultaneously enhancing the capacity of hromadas to deliver public services and take an active role in the recovery and reconstruction processes, in line with EU accession requirements.

#### **Spheres of Activity**

The Programme offers direct support to hromadas while working closely with national and regional partners to enhance policy coherence for recovery and development.

Hromadas can submit requests through the Polaris website for consultations on administrative services accessibility, support for starostas, and education governance. During the reporting period, 354 requests for such support were received.

To inform hromadas about the opportunities for support and development offered by the Programme, a series of information sessions was held in Zhytomyr, Dnipropetrovsk, Ivano-Frankivsk, and Kirovohrad oblasts. These sessions brought together representatives of local governments across the oblasts, as well as regional authorities, contributing to broader outreach and an improved understanding of available support tools and the needs of hromadas.

Polaris also announces open calls for local governments, enabling hromadas to choose priority areas of support. As a result of these calls, cooperation was initiated with 95 hromadas across 22 oblasts in the following areas: education at the local and regional levels, starostas' capacity development, locally-led recovery, prevention and response to domestic violence, local citizens engagement, and support for accessibility of administrative services.

To coordinate efforts and implement systemic reforms, the Programme signed memorandums of cooperation with the Ministry for Communities and Territories Development of Ukraine, the Ministry for Digital Transformation of Ukraine, the Ministry for Education and Science of Ukraine, the National Agency of Ukraine on Civil Service, and the State Agency for Restoration and Infrastructure Development of Ukraine.



# LOCALLY-LED RECOVERY

**Direction of Action** 

The newly introduced thematic sphere "Locally-Led Recovery" combines ambitious tasks related to the development and implementation of strategic and spatial planning documents – such as Development Strategies, Integrated Spatial Development Concepts, and Comprehensive Spatial Development Plans – and establishes a methodological and institutional framework grounded in SALAR International's expertise.

The Locally-Led Recovery team is developing a unique, evidence-based, digital, and scenario-driven approach to hromada recovery, which includes a GIS component and a flexible methodology. This approach ensures active involvement of hromadas and local communities in reconstruction processes, enabling adaptability to changing conditions and offering the potential for scaling across Ukraine.






## **Key Achievements**

- Following an open call for applications, 121 hromadas from 12 frontline and border oblasts of Ukraine expressed interest in partnering with the Programme. A rigorous, multi-criteria selection process was conducted, involving analytical and qualitative assessments as well as field visits, ensuring a well-founded and transparent selection of 13 hromadas from 7 oblasts. The selection process was carried out in partnership with the Ministry for Communities and Territories Development of Ukraine
- In March 2025, during the "Recovery in Action" conference, the Programme's approach to working with partner hromadas was publicly presented, and memorandums of cooperation were signed. A team of senior experts in spatial planning, strategic development, and local selfgovernment launched joint efforts to deliver tailored support
- An eight-stage methodology for supporting partner hromadas has been developed, implementation partners were selected to carry out specific tasks and deliverables, and the first working visits have begun
- The first phase of work including initial data collection, needs assessment, and agreement on further areas of cooperation – has been successfully completed

Polaris

The recovery of hromadas after the full-scale war is of strategic importance for Ukraine's sustainable development. The responsibility for creating effective recovery methodologies lies with the Ukrainian professional community, while the strong interest from hromadas, national partners, and leading expert groups – demonstrated by their active participation in the Programme's tenders for the development of strategic documents – confirms the high level of trust in Polaris

# SUPPORT FOR ADMINISTRATIVE SERVICES ACCESSIBILITY

**Direction of Action** 

Polaris experts worked to improve the development and accessibility of administrative services in hromadas. Their efforts included supporting the Administrative Service Centres (ASC), including trainings staff, developing digital solutions, providing consultations, and conducting audits. In cooperation with partners, the team strengthened the professional ASC community, facilitated the integration of tax and social services, and prepared analytical and regulatory proposals. The key priorities were inclusivity, sustainability, and responsiveness to the needs of diverse population groups.

# **CROSS-CUTTING ISSUE:** INTEGRATING THE VETERAN PERSPECTIVE INTO LOCAL GOVERNANCE

The Challenge

The reintegration of veterans is a complex and multidimensional process that remains relevant both during the war and throughout the recovery period. It involves addressing physical and psychological consequences, supporting the well-being of veterans' families, and enabling veterans to fully participate in civilian life.



## **Our Approach**

- Supporting hromadas in improving service delivery and increasing outreach to veterans, women veterans, and their families
- Strengthening the role and capacity of local self-government in implementing the national strategy and fostering multilevel dialogue on veteran policy
- Enhancing the knowledge and competencies of local government staff who work with veterans and their families

#### What We Achieved

- Organised a series of meetings with representatives of the Ministry of Veterans Affairs, the Ministry of Economy, the State Employment Service, oblast military administrations, as well as with Veteran Hub and "Prostir Mozhlyvostei" to align approaches and strengthen Programme support
- Developed and launched a training series titled "Ethics of Interaction and Communication with Veterans and Their Families" targeting starostas and ASC administrators

# STAROSTA INSTITUTION DEVELOPMENT

2025

**Direction of Action** 

We are strengthening hromadas' capacity to bring services closer to residents through the institution of the starosta – the representative of local self-government at the community level. This area focuses on the evolving role of the starosta, the practical implementation of their responsibilities, and the development of a professional network.

# **Expert Deliverables**

In cooperation with the Parliamentary Committee on Local Self-Government and the NGO DESPRO, two studies were conducted and presented: "Starosta's Mandate: Legislative Framework and Practice" (based on 3,700 respondents) and "Oversight Functions of the Starosta" (based on 2,400 respondents)

# EDUCATION: NATIONAL LEVEL



### **Direction of Action**

We supported the Ministry of Education and Science of Ukraine (MoES) in strengthening its capacity to make informed decisions on education financing, particularly under wartime conditions. The Programme contributed to enhancing hromadas' understanding of the education subvention formula, improved analytical capacity through the use of digital tools and international best practices, and worked to make education funding more transparent, adaptive, and learneroriented.

## **Key Achievements**

An updated Education Indicators
 Dashboard was developed and presented, featuring six analytical modules and video tutorials for each.
 This tool enables analysis of the status and development trends of general secondary education and strengthens data-driven decision-making capacity

- Information briefs on the calculation of the 2025 education subvention for each hromada were developed and printed. These materials promoted funding transparency, improved cooperation with hromadas, and supported the decentralisation of education
- Policy briefs were prepared for the MoES covering the allocation of education subvention from local budgets in exceptional cases, monthly planning, funding for students with special educational needs, class size standards, and norms for distance learning

- A study visit to France was organised for delegations from the Ministry of Education and Science and the Ministry of Finance of Ukraine. The programme focused on approaches to education financing during martial law, statistical data collection methods, and practices related to teacher remuneration
- Support was provided to the newly established Directorate for Strategic Planning and Recovery at the MoES to upgrade equipment for effective work and to deliver training aimed at strengthening the analytical competencies of its staff

# EDUCATION: LOCAL AND REGIONAL LEVELS

**Direction of Action** 

We provide systematic support to hromadas and regions in developing effective education governance and the efficient use of resources at the local and regional levels. We pay particular attention to the reform of school networks, the implementation of upper secondary school reform, building communication among education stakeholders to reduce resistance to change, strengthening the resilience of education systems during wartime, and ensuring equitable access to quality educational services for all learners.



## **Key Achievements**

- Systematic and methodological support to 10 partner hromadas in forming effective school networks and implementing the upper secondary school reform, including educational network planning, profiling, and capacity-building for education management at the school, hromada, and regional levels
- Continued cooperation with the Ministry of Education and Science and local government associations to ensure access to education for learners in temporarily occupied, de-occupied, and frontline territories of Ukraine, as well as those abroad.
- Delivery of open webinars on high-demand topics
- Dissemination of best nationwide practices for education reform
- Publication of the updated methodological manual "Upper Profiled School: Steps Towards Establishment, Version 2.0", a key tool for education managers and school principals
- Development of methodological and practical tools for conducting dialogue-based meetings within hromadas



# CROSS-CUTTING ISSUE: GENDER EQUALITY

2025

The Challenge

Promoting gender equality at the local level remains challenging, as the impact of war further strains resources and exacerbates inequalities, and it is sometimes seen as politicised or externally imposed. At the same time, there is a need to raise awareness and to develop the skills and resources required to address gender equality and prevent gender-based violence in hromadas.



## Our Approach

Our approach is adaptive and focused on supporting local government leadership and staff in applying gender-sensitive practices. It is grounded in human rights, equality, non-discrimination, and participation principles that are embedded throughout all programme materials.

#### In our work, we strive to:

- Clarify that gender mainstreaming = better governance
- Highlight the experience of hromadas already taking action
- Show that every official can address the diverse needs of women and men
- Emphasise the human dimension of results

We take into account the unique context of each hromada, while consistently upholding the principles of dignity, transparency, and inclusiveness

### What We've Achieved

- 8 hromadas have launched partnerships with the Programme to address and prevent domestic violence
- Supported the accession of the All-Ukrainian
   Association of Hromadas to the Alliance for Gender Responsive and Inclusive Recovery of Ukraine
- Trainings for local self-government representatives,
   Administrative Service Centre staff, education managers,
   and starostas are regularly conducted in cooperation with other programme components and relevant central government bodies

- In partnership with the "Support to Associations" component, gender equality has been integrated into recommendations for the development of local government associations
- A national forum of associations was held on "The Role of Women in Local Self-Government"







# SUPPORT TO LOCAL GOVERNMENT ASSOCIATIONS

**Direction of Action** 

We worked to enhance the role of democratic, membership-based associations of local self-government bodies as key drivers of Ukraine's recovery and European integration. Our efforts focused on consolidating their positions on priority issues, building institutional capacity, and fostering effective dialogue between hromadas and authorities at all levels. This work was carried out through consistent support aimed at strengthening the organisational capacity of associations, delivering training centred on the Programme's thematic priorities, and addressing the current challenges facing local self-government.





## **Key Achievements**

- Signed memoranda of cooperation with three nationwide local government associations — the All-Ukrainian Association of United Territorial Communities, the All-Ukrainian Association of Hromadas, and the Ukrainian Association of Rayon and Oblast Councils — to strengthen democratic membership culture, promote consolidation, and foster multilevel dialogue
- Organised a series of interregional forums with members of the All-Ukrainian Association of United Territorial Communities to build hromadas' capacities and support dialogue with regional authorities
- Together with the Programme's expert teams, conducted 12 regional events for representatives of over 800 members of local government associations on topics including education, accessibility of administrative services, veteran policy development, gender equality, and inclusion

- Held Ukraine's first-ever Forum of Regional Associations, resulting in the adoption of a resolution on the role of regional self-government within the multilevel governance system and an agreement on further cooperation to develop a nationwide network of regional associations
- Convened three policy dialogue platforms for political leaders and leadership of national associations, focusing on public investment and gender-responsive budgeting, education, service accessibility, and veteran policy at the local level
- Conducted three trainings for board members of associations to strengthen their institutional and organisational capacity
- In partnership with the Cities4Cities team, facilitated the participation
  of leadership and political representatives from four national
  associations at the Cities Forum in Krakow a flagship European
  Commission event dedicated to municipal development

**Direction of Action** 

The international cooperation track of the Polaris Programme is implemented through Cities4Cities – an initiative launched in 2022 with the support of SALAR International to help hromadas establish intermunicipal partnerships across the globe.

# **Key Achievements** in progress

• In May 2025, the Second Swedish-Ukrainian Municipal Partnership Forum took place in Lidingö, Sweden, featuring participation from 13 pairs of hromadas from Ukraine and Sweden

 Over 1,000 local government representatives began training on the online course "European Integration: Impact and Opportunities for Hromadas" on the Cities 4 Cities

Academy platform, with 33% having successfully completed the course

 Held 12 thematic online sessions "Fridays with Cities4Cities" to develop competencies in international cooperation

 Organised the Ideas Residence seminars in Lviv for experience-sharing, attended by 60 hromada representatives, including 20 young municipal professionals

 Facilitated the participation of hromada heads in the Cities Forum (Krakow) and the Ukraine Recovery Conference (Rome). During the Rome conference, Cities 4 Cities moderated a discussion on the role of municipalities in resilience, cohesion, and European integration

# CROSS-CUTTING ISSUE: CITIZENS ENGAGEMENT

#### Challenge

Informing residents, gathering feedback, and involving the hromada in decision-making are essential components of every area of local self-government activity. However, hromadas face a number of systemic challenges along the way – including a lack of institutional frameworks, insufficient resources, and limited relevant skills.



## Our Approach

We combine open training events for local government representatives with a tailored approach to working with partner hromadas. Our goal is to provide both foundational capacity building in communication, feedback, and engagement, and targeted expert support.


### What We Have Achieved

- 10 hromadas have launched partnerships with the Polaris Programme in the area of public communication and engagement, with memorandums signed and individual cooperation roadmaps developed
- Public consultation has begun on the Model Territorial Hromada Charter – a key tool for enabling resident participation in decision-making
- Collaboration has been strengthened with other thematic areas of the Programme – including education, ASCs, intermunicipal cooperation, and citizens engagement – to integrate communication approaches across all areas of local governance

- Over 20 open training events have been held for nearly 800 participants – including local government officials, ASC staff, education sector professionals, communication specialists, starostas, and CSO representatives
- 3 audits of communication strategy have been conducted in hromadas, with analytical recommendations provided to strengthen information sharing and public engagement

# FISCAL DECENTRALISATION

**Direction of Action** 

We provided expert and analytical support for the reform of the personal income tax (PIT) allocation system based on the taxpayer's place of residence. We contributed to strengthening hromadas' financial capacity by improving approaches to managing their revenues. Our work focused on enhancing decentralisation policies, supporting PIT reforms, managing public investments, and optimising multilevel governance. This included active dialogue with central government bodies and local government associations to ensure coordinated actions and broad stakeholder engagement, keeping reform implementation transparent, coherent, and aimed at sustainable local self-government development.



### **Key Achievements**

Strengthened hromadas' involvement in the administration of local taxes and fees through participation in working groups, webinars, and development of proposals for legislative and regulatory acts

Provided regular expert support to the Ministry for Development regarding the execution of local budgets and amendments to budget legislation

Conducted a joint study with the U-LEAD with Europe Programme on the impact of the new PIT crediting system and presented its findings to key stakeholders at public events


Prepared and submitted proposals to central authorities for amendments to budget and tax legislation, reflecting the needs and interests of local hromadas

Supported hromadas in implementing the public investment management reform by organising a series of webinars for local government officials responsible for financial and investment activities, as well as meetings for hromada leadership and political association leaders

Established close cooperation with national and international partners to coordinate efforts and avoid duplication in reform work

Updated the hromada financial capacity dashboard and introduced its regular monitoring to enhance the effectiveness and transparency of management decisions at all governance levels

# **SWEDISH SUPPORT:** SIDA AND SALAR



Sida — The Swedish International Development Cooperation Agency. It is a government agency that, on behalf of the Swedish government and parliament, works to improve the living conditions of people living in poverty and facing oppression around the world.
